WHEREAS:

- (i) The NGO is engaged in Sports and Education;
- (ii) The NGO has sought to engage in developing amenities for sports for students in their college; hereinafter referred to as "**the Project**"; (Refer to Annexure 1)
- (iii) The NGO has approached the Foundation with a request to facilitate the fundraising for the realization of the Project by 31st September, 2018;
- (iv) The Foundation has agreed solely to facilitate an arrangement for fundraising for the realization of the Project, subject to the NGO meeting certain terms and conditions as may be stipulated by the Foundation in the terms of the MOU, the Foundation however clarifies that they are neither representing to the NGO or guaranteeing in any way that any funds will be raised as a result of its facilitation/campaign;
- (v) In view of the aforesaid, the Foundation and the NGO have agreed to enter into this MoU to record the terms of their understanding and their responsibilities towards the Project, in particular, in relation to an arrangement for fundraising for the realization of the Project.

The Foundation and the NGO are hereinafter collectively called "**Parties**" and individually referred to as "**Party**".

TERMS OF THE MOU

OBLIGATIONS OF THE PARTIES

(A) THE FOUNDATION

- 1) The Foundation will make reasonable efforts to facilitate an arrangement for fundraising by 31st September, 2018. The Foundation makes no representation nor guarantee that any sums will indeed be raised as a result of such facilitation/campaign for fundraising for the realization of the Project and the NGO acknowledges this. The Foundation makes no representation nor guarantee that it shall itself provide any funds towards the realization of the Project and the NGO acknowledges this.
- 2) The Foundation pledges to match public donations received through the campaign to a maximum of INR 2.5 lakh. This matching grant pledge will strictly be subject to amount raised through public contribution

- 3) In case the amount raised through public donations is less than INR 2.5 lakh, the Foundation will match the same. In case the amount raised exceeds INR 2.5 lakh, the Foundation will only match the amount up to and not more than INR 2.5 lakh
- 4) The Foundation further agrees to make a one-time payment to danamojo, an online donation management platform for facilitating the NGO for the purpose of raising funds for the Project for and on behalf of the NGO.

(B) THE NGO

- 1) The NGO shall utilise any funds raised and received by it towards the realization of the Project, solely for the completion of the Project and in accordance with any terms and conditions which may be specified by the Foundation from time to time.
- 2) The NGO shall provide all information or material and assistance to the Foundation or its representatives and consultants, as specified by the Foundation in relation to the Project and the Foundation shall be free to share or use or make public such information as it deems fit.
- 3) The NGO shall maintain regular accounts and records in relation to the Project, in particular, in relation to the utilisation of any funds raised for the Project and shall provide prompt access to the Foundation or its representatives and consultants to any such information or records.
- 4) The NGO shall submit utilisation reports, at the frequency specified and in the prescribed format provided by the Foundation to establish to the satisfaction of the Foundation that any funds raised have been/are being successfully utilised towards successful completion of the Project.
- 5) The NGO shall provide access to its records and information and facilitate interaction with any participants or beneficiaries or persons in relation to the Project, to the Foundation or its representatives and consultants, including in relation to any monitoring or evaluation exercise which the Foundation may wish to have conducted with regard to the Project.
- 6) The NGO agrees to avail the services of danamojo for the purpose of raising funds for the Project and shall incorporate on its website the application(s) and associated software provided by danamojo for the purpose of raising funds for the Project for the duration of the fundraising, as agreed between the Parties, in order to start accepting any funds which may be donated for the Project.
- 7) The name and logo (as provided by the Foundation) of the Foundation will be mentioned on all publicity material concerning the Project including website, social media, handouts, brochures, posters etc created by the beneficiary/ NGO

- 8) The Foundation will have the rights to promote, and disseminate information about its association with the Project/ NGO as a supporter
- 9) The Foundation's branding will appear on the website of the NGO where mention is made of the Project, as specified by Foundation.
- 10) The Foundation's branding to appear on the website "Homepage", "About" page and "Partners" page or section as specified by Foundation.

1) Indemnity

NGO (Indemnifying Party) agrees to indemnify and keep indemnified individually, fully and promptly, the other (Indemnifying Party) and/or its employees from and against all costs, claims, demands, liabilities, expenses, direct damages or losses arising out of or in connection with the Indemnifying Party's gross negligence or willful breach of the terms of this MoU.

2) Refund

Reporting default/ unsatisfactory execution of the project as per agreed terms with YES FOUNDATION leading to failure to achieve the projected goals and impact will lead to the NGO refunding the donation amount received as matching grant from YF as through the campaign

(C) OTHER STIPULATIONS

- 1) Additions to and modifications of this MOU are only valid if they have been ratified by all the Parties, in writing.
- 2) Except as required by law, the Parties shall ensure that any confidential information disclosed by one Party to another in accordance with this MOU or which comes into the other Party's knowledge under this MOU shall not be used for any purposes other than those permitted under this MOU and shall not be disclosed to any third party.
- 3) This MOU shall commence from the 1st June, 2018 hereof and shall end on 31st March, 2019
- 4) Notices under this MOU shall be in writing, with acknowledgement for receipt and shall be sent to the other Parties marked for the attention of the person at the address set out for such party in this MOU
